- **4-A)** Board Chair -- The board chair has no updated information.
- **4-B)** Board Members Nothing presented at this time.
- **4-C)** Guest 6-I: Discussion on banking information was presented at this time. Marie Bittner presented information on the different interest rates and pros and cons concerning the three (3) local individual banking groups. Jeanne Voegele from Dakota Community Bank answered board questions that were presented. Lisa Gerving made a motion, seconded by Matt Miller, to move all of the school accounts to Dakota Community Bank. Motion unanimously carried.

Mr. Barry left the Board Meeting at 7:49 p.m.

Emily Kottre discussed her concerns regarding bullying within the school district setting. She indicated that she had not filed any paperwork to bring this to the attention of the administration and was advised that the grievance procedure paperwork was located on the school website.

## **4-D)** Superintendent/Elementary Principal:

- COVID-19 Update Plan Mr. Remboldt presented, on behalf of Mr. Barry, information concerning where the school is at with its COVID-19 procedures. Mr. Remboldt discussed the lunchroom along with the salad bar. Marie Bittner made a motion, seconded by Matt Miller, not to require masks on the buses. Motion unanimously carried.
- 2. Update Discussion on Legislation Mr. Remboldt presented, on behalf of Mr. Barry, that unless there are additional executive orders by the governor the virtual learning component granted, due to the pandemic, would expire on June 30, 2021.

## **4-E)** Secondary Principal/AD:

 Hiring of coaches – Matt Miller moved, seconded by Lisa Gerving, (Marie Bittner abstained) to hire Stephanie Heck as elementary volleyball coach. Motion carried.

Marie Bittner moved, seconded by Lisa Gerving, to approve the hiring of track coaches Bobby Schneider and Trista Dakken. Motion unanimously passed. Hebron has 31 children and Glen Ullin has 15 children interested in participating.

Tammy Grosulak resigned her position as JV and C Boys' Basketball Coach. Lisa Gerving made a motion, seconded by Matt Miller, to accept her resignation. Motion unanimously carried.

There is currently an opening for lead varsity volleyball coach with the resignation of Carrie Duppong. Lisa Gerving made a motion, seconded by Matt Miller, (Marie Bittner abstained) to accept her resignation. Motion carried.

The open Drama position was discussed. Marie Bittner made a motion, seconded by Matt Miller, to offer the position to Christine Lawson who accepted. Motion unanimously carried.

- 2. At this time Mr. Remboldt was unsure of the number of participants for golf. He has not heard of any region changes and he will look into getting banners for football, golf and baseball.
- **4-F)** Mr. Bollom gave an update on how the 3<sup>rd</sup> quarter ended. Mr. Bollom is working hard to build relationships within the community that embrace parental input regarding their children's learning.

The new behavior model MTSS will be implemented in August 2021.

- **6-E) School Improvement Update:** The school improvement team will meeting on March 11, 2021.
